**ADOPTION STATEMENT**

This statement is published by Ipswich Borough Council to fulfil the requirements of Regulation 14 and Regulation 35 of the Town and Country Planning (Local Planning) (England) Regulations 2012. The '*Public Open Space Supplementary Planning Document*' and the '*Ipswich Garden Suburb Supplementary Planning Document*' were adopted by Ipswich Borough Council on 22 March 2017.

Copies of the Public Open Space Supplementary Planning Document, the Ipswich Garden Suburb Supplementary Planning Document, the Adoption Statement, Strategic Environmental Assessment (Appropriate Assessment), Habitats Regulations Assessment (Appropriate Assessment), Updated Consultation Statement are available for public inspection at the locations set out below and on the Council's website.

The Public Open Space SPD provides detailed guidance on the protection of existing open spaces and outdoor sport and recreation facilities from inappropriate development; the requirements for new open spaces and outdoor sport and recreation facilities provision associated with new development and advice on maintenance; and the enhancement of the Borough's tree canopy cover.

The Ipswich Garden Suburb SPD provides a guide for the coordinated development of the Ipswich Garden Suburb area. The SPD sets out a vision for the Ipswich Garden Suburb and identifies the infrastructure and strategies needed to ensure the comprehensive delivery of the development. The SPD supports policy CS10 'Ipswich Garden Suburb' of the 2017 Ipswich Local Plan.

Any person with sufficient interest in the decision to adopt an SPD may apply to the High Court for permission to apply for judicial review of the decision to adopt an SPD in accordance with Regulation 11 of the Town and Country Planning (Local Planning) (England) Regulations 2012. Any such application must be made no later than **3 months** after the date on which the SPD was adopted and in any case **not later than 22 June 2017**.
