

IPSWICH BOROUGH COUNCIL
(OFF-STREET PARKING PLACES) ORDER (2) 2024

Ipswich Borough Council under Sections 32, 35 and 35A and Schedule 9 (Part IV) of the Road Traffic Regulation Act 1984, the Local Authority Traffic Orders (Procedure) (England and Wales) Regulations 1996 and all other enabling powers propose to make the above Order. The general nature and effect of this Order will be to amend the Ipswich Borough Council (Off-Street Parking Places) Order 2022 (as amended) by:

- * inserting a £12 tariff for stays in excess of 5 hours at the Crown parking place (Charles Street, Ipswich), where the vehicle exits by 08:00 on the next day (this does not affect the validity of the £2.50 after 2pm special offer Monday to Friday) and inserting the sale of season tickets at the same parking place as 12 months (valid Monday to Friday) = £1,309;
- * removing free parking for up to 3 hours at the Crown parking place for disabled blue badge holders;
- * allowing disabled blue badge holders to park for free for up to 3 hours in any space (rather than just blue badge holder spaces) when displaying a valid badge and disc in the relevant position at the Bond Street, Elm Street, Regent, St. Peter's Dock, Upper Orwell Street (North), Upper Orwell Street (South), William Street, Fore Street, Norwich Road Shoppers and Smart Street parking places.
- * varying the charges that apply at the following parking places within the Borough of Ipswich to insert a special tariff that will apply on days when there is a football match scheduled to take place at the Portman Road ground during a period from 3 hours before the commencement of the match ("kick off") to 1 hour after kick off (with no changes to any other parking places listed within the Schedule):
