

IPSWICH BOROUGH COUNCIL (SUFFOLK COUNTY COUNCIL (BOROUGH OF IPSWICH) (STOPPING, WAITING AND LOADING PROHIBITIONS AND RESTRICTIONS AND ON-STREET PARKING PLACES) (CONSOLIDATION) ORDER 2019) ON-STREET PARKING PLACES ORDER 2025

WHEREAS IPSWICH BOROUGH COUNCIL ("the Council") wishes to amend certain aspects of the Suffolk County Council (Borough of Ipswich) (Stopping, Waiting and Loading Prohibitions and Restrictions and On-Street Parking Places) (Consolidation) Order 2019 (as amended) by:

IPSWICH BOROUGH COUNCIL pursuant to arrangements made in accordance with Regulations made under Section 19 of the Local Government Act 2000 with the Suffolk County Council in exercise of the powers of the County Council under Sections 1, 2, 4, 45 and 46 of the Road Traffic Regulation Act 1984 ("the 1984 Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Schedule 9 Part III of the 1984 Act and Part 6 of the Traffic Management Act 2004 ("the 2004 Act"), MAKES THE FOLLOWING ORDER:

1. The provisions of the Suffolk County Council (Borough of Ipswich) (Stopping, Waiting and Loading Prohibitions and Restrictions and On-Street Parking Places) (Consolidation) Order 2019 ("the 2019 Order"), as amended, shall have effect as if set out in full in the 2019 Order, save that:

* revision 2 of the Map Tile bearing reference GJ123 shall be replaced by the amended revision 3 of the Map Tile bearing the same reference attached to this Order, and Schedule 7 of the 2019 Order shall be amended accordingly.

* revision 4 of the Map Tile bearing reference GK123 shall be replaced by the amended revision 5 of the Map Tile bearing the same reference attached to this Order, and Schedule 7 of the 2019 Order shall be amended accordingly.

* revision 2 of the Map Tile bearing reference GL121 shall be replaced by the amended revision 3 of the Map Tile bearing the same reference attached to this Order, and Schedule 7 of the 2019 Order shall be amended accordingly.

* revision 2 of the Map Tile bearing reference GL122 shall be replaced by the amended revision 3 of the Map Tile bearing the same reference attached to this Order, and Schedule 7 of the 2019 Order shall be amended accordingly.

* revision 3 of the Map Tile bearing reference GL123 shall be replaced by the amended revision 4 of the Map Tile bearing the same reference attached to this Order, and Schedule 7 of the 2019 Order shall be amended accordingly.

* revision 2 of the Map Tile bearing reference GM122 shall be replaced by the amended revision 3 of the Map Tile bearing the same reference attached to this Order, and Schedule 7 of the 2019 Order shall be amended accordingly.

2. This Order may be cited as the Ipswich Borough Council (Suffolk County Council (Borough of Ipswich) (Stopping, Waiting and Loading Prohibitions and Restrictions and On-Street Parking Places) (Consolidation) Order 2019) On-Street Parking Places Order 2025 and shall come into force on 10th November 2025.


