

ROAD TRAFFIC REGULATION ACT 1984

IPSWICH BOROUGH COUNCIL

(TOWER RAMPARTS AND LLOYDS AVENUE PROHIBITION OF MOTOR VEHICLES) ORDER 2025

Ipswich Borough Council under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers proposes to make the above Order, the effect of which will be to do the following within the Borough of Ipswich:

- (1) Impose a new prohibition of motor vehicles at all times on the section of Tower Ramparts between its junction with Peel Street and a point 51 metres east of its junction with Peel Street; with exemptions for access to premises on this section of Tower Ramparts or premises accessed off this section of Tower Ramparts, for licensed hackney carriages ("taxis"), for vehicles to which a special permit has been issued and is correctly displayed, and for vehicles being used for or in connection with funerals;
- (2) Revoke the existing prohibitions of motor vehicles that apply on Lloyds Avenue in the Ipswich Borough Council (Prohibition of Entry, Prohibition of Motor Vehicles) Amendment Order 2005-02;
- (3) Impose a new prohibition of motor vehicles at all times on the section of Lloyds Avenue between its junction with Tower Ramparts and a point 54 metres north of its junction with Cornhill; with exemptions for goods vehicle being used to enable goods to be loaded onto or unloaded from the vehicle to or from premises on Lloyds Avenue, licensed hackney carriages ("taxis"), for vehicles to which a special permit has been issued and is correctly displayed, and for vehicles being used for or in connection with funerals; and
- (4) Impose a new prohibition of motor vehicles at all times on the section of Lloyds Avenue between its junction with Cornhill and a point 54 metres north of its junction with Cornhill, with an exemption for vehicles to which a special permit has been issued and is correctly displayed.

Exemptions will also apply for the emergency services, for statutory undertakers, for the delivery or collection of postal packets by a universal service provider and in certain other cases.
