| <u>IP/25/00935/TALF</u> | 155 Henley Road | Works to trees protected by TPO 2 of 2023: Removal of Lawson Cypress; crown lift Sycamore over carriageway to height of 5.2m; crown lift Horse Chestnut to 5.2m over carriageway and remaining canopy to 2.6m and reduction of lower branch overhanging entrance to site by 5.0m and two upper branches by 2.5m. CASTLE HILL (Northwest Area) |
| <u>IP/25/00929/CALF</u> | 41 Graham Road | Works to trees: Reduce Walnut (T1) all around by 2 metres; reduce back Tree of Heaven (T2) from footpath and road by 2.5 metres and prune back on garden side by 1.5 metres. ST MARGARETS (Central Area) |
