Notice is hereby given that on 23 March 2022 in accordance with Section 23 of the Planning and Compulsory Purchase Act 2004 and Regulations 17 and 26 of the Town and Country Planning (Local Planning) (England) Regulations 2012 (as amended), Ipswich Borough Council adopted the Core Strategy and Policies Development Plan Document (DPD) Review, the Site Allocations and Policies (Incorporating IP-One Area Action Plan) DPD Review, Policies Map and IP-One Area Action Plan Inset Policies Map.

The adopted Core Strategy and Policies DPD Review is a strategic document setting out the vision, objectives and spatial planning strategy for the Borough of Ipswich up to 2036, and contains policies to facilitate sustainable development. The Site Allocations and Policies (Incorporating IP-One Area Action Plan) DPD Review allocates sites for development and identifies sites or areas for protection across the whole of the Borough. The Policies Maps illustrate geographically the application of the policies in the adopted development plan.

The Core Strategy and Policies DPD Review and the Site Allocations and Policies (Incorporating IP-One Area Action Plan) DPD Review will form the Ipswich Local Plan and will supersede the previously adopted Ipswich Local Plan 2011-2031.

Independent Planning Inspectors as part of a Public Examination considered the Core Strategy and Policies DPD Review and the Site Allocations and Policies (Incorporating IP-One Area Action Plan) DPD Review, which formed the emerging Ipswich Local Plan 2018-2036 with the Examination Formal Hearing held between 24 November and 16 December 2020.The Council received the Inspectors' report on 17 February 2022 and published it on 28 February 2022. The Plan was found legally compliant and sound subject to inclusion of the Inspectors' Main Modifications. The newly adopted Core Strategy and Policies DPD Review and Site Allocations and Policies (Incorporating IP-One Area Action Plan) DPD Review, forming the Ipswich Local Plan 2018-2036 incorporate the recommendations of the Inspectors as set out in their Report.

Any person aggrieved by the adoption of the Core Strategy and Policies DPD Review or the Site Allocations and Policies (Incorporating IP-One Area Action Plan) DPD Review may make an application to the High Court under Section 113 of the Planning and Compulsory Purchase Act 2004 (as amended) on the grounds that the document is not within the appropriate power of the local planning authority and/or a procedural requirement has not been complied with. Any such application must be made not later than the end of the period of six weeks starting when the new Ipswich Local Plan 2018-2036, consisting of the Core Strategy and Policies DPD Review and the Site Allocations and Policies (Incorporating IP-One Area Action Plan) DPD Review, was adopted.
