What is proposed?: To consider and determine how to proceed in respect of the operation of a number of the Council's subsidised bus services.

Why are the changes being introduced?: The Council subsidises a number of bus services which are not commercially viable. The current contracts (known as 'service subsidy agreements') expire on 25th September 2022 and decisions are now required on how to proceed with their replacement, taking into account the extent to which there is a continuing need to provide such services together with the level of funding that the Council can afford to commit to this function. The matter is going to the Council's Executive Committee because the proposals include a reduction in the level of provision on some services (for financial reasons) and the Council's Scheme of Officer Delegations does not allow officers to make a decision to withdraw public services, and also because at least one of the proposed new service subsidy agreements is beyond the maximum limit that Contract Standing Orders allows officers to award.

What evidence is being used to support this Equality Impact Assessment, and how is it being used?: Statistics of usage of the existing IBC subsidised bus services, including the level of concessionary patronage and the subsidy per passenger.

How will this change be implemented?: If approved by the Council's Executive Committee, new

service subsidy agreements will be entered into in respect of those subsidised bus services that are to continue, where as for those that are not formal notification will be made to the affected bus operator.

Please provide an explanation of this impact and actions to mitigate any adverse impact, or further promote positive impact.: Explanation - Stats identify that the majority of older people use the buses that are above the red line in the Executive report, however consideration is given that all bus services are used by older people.

Actions / Mitigation - Actively liaise with bus service passengers and relevant groups where visible to provide information on alternative options to lesson the impact of any proposed change to services.
