

**ROAD TRAFFIC REGULATION ACT 1984**  
**IPSWICH BOROUGH COUNCIL (SUFFOLK COUNTY COUNCIL (BOROUGH OF**  
**IPSWICH) (STOPPING, WAITING AND LOADING PROHIBITIONS AND**  
**RESTRICTIONS AND ON-STREET PARKING PLACES) (CONSOLIDATION)**  
**ORDER 2019) AMENDMENT ORDER 2022**

WHEREAS IPSWICH BOROUGH COUNCIL wishes to amend certain aspects of the Suffolk County Council (Borough of Ipswich) (Stopping, Waiting and Loading Prohibitions and Restrictions and On-Street Parking Places) (Consolidation) Order 2019, as amended, by:-

1. Varying the existing charges and maximum stay for parking at various on-street paid for designated parking places within the Borough of Ipswich (exemptions will apply for holders of a disabled person's blue badge).
2. Varying the charging hours for parking at various on-street paid for designated parking places within the Borough of Ipswich.
3. Introducing a 'Convenience Fee' of £0.10 for the use as a method of payment for parking charges at any on-street paid for designated parking place within the Borough of Ipswich any electronic programme as the Council may make available for that purpose.
4. Making other miscellaneous changes.

IPSWICH BOROUGH COUNCIL pursuant to arrangements made in accordance with Regulations made under Section 19 of the Local Government Act 2000 with the Suffolk County Council in exercise of the powers of the County Council under Sections 1, 2, 4, 45 and 46 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Schedule 9 Part III of the Act and Part 6 of the Traffic Management Act 2004 ("the 2004 Act") MAKES THE FOLLOWING ORDER:-

## COMMENCEMENT, CITATION AND REVOCATION

- (1) This Order may be cited as the Ipswich Borough Council (Suffolk County Council (Borough of Ipswich) (Stopping, Waiting and Loading Prohibitions and Restrictions and On-Street Parking Places) (Consolidation) Order 2019) Amendment Order 2022 and shall come into operation on 1<sup>st</sup> August 2022.

## AMENDMENTS TO PREVIOUS ORDER

- (2) The following definition is added into paragraph 1.1 ('Interpretation') of the Suffolk County Council (Borough of Ipswich) (Stopping, Waiting and Loading Prohibitions and Restrictions and On-Street Parking Places) (Consolidation) Order 2019, as amended, ("the 2019 Order"):

"convenience fee" means a fee charged in accordance with Schedule 1A for the use of any electronic programme as the Borough Council may make available as a method of payment for paying a parking charge in accordance with this Order;

- (3) Paragraph 3.5 of the 2019 Order ('Parking charge') is amended as follows:

3.5 No person shall leave or cause to be left any vehicle in a pay and display parking place during the permitted hours for that parking place except upon payment of a parking charge as specified in Schedule 1 and, where applicable, the convenience fee as specified as in Schedule 1A.

- (4) The following paragraph shall be added to the 2019 Order following paragraph 3.8 of that Order:

3.8A The Borough Council may, at its complete discretion, decide that in respect of the payment of parking charges for any individual parking place(s) specified in this Order the only method of payment acceptable shall be by the purchase of an electronic ticket by utilising any electronic programme as the

Borough Council may make available for the purpose, and shall ensure that signage stating that this is the case shall be displayed in any parking place(s) to which this paragraph applies.

- (5) Notwithstanding the provisions of Part 3 of the 2019 Order and the Map Schedules to the 2019 Order (as amended) the charging hours for all of the parts of roads identified in the Map Schedules to the 2019 Order (as amended) shall be as per Schedule 1 to this Order (which replaces Schedule 1 of the 2019 Order).
- (6) Schedule 1 of this Order shall replace Schedule 1 of the 2019 Order.
- (7) Schedule 1A of this Order shall be added to the 2019 Order following Schedule 1 of that Order.
- (8) Other than as amended by this Order, the 2019 Order remains in full effect.

## SCHEDULE 1A – CONVENIENCE FEE

The Borough Council may, at its complete discretion, choose to provide an option for the payment of parking charges for leaving a vehicle in a parking place covered by this Order whereby the charge may be paid electronically utilising an electronic programme that the Borough Council may make available for the purpose. The Borough Council may, at its complete discretion, decide in accordance with paragraph 3.8A of this Order that, in respect of any individual parking place(s) covered by this Order that this shall be the only acceptable method of payment.

Where a parking charge is paid electronically by utilising an electronic programme that the Borough Council may make available for the purpose, either as an option or as the only acceptable method of payment, then in addition to the parking charge the Convenience Fee listed in the table below shall also be required to be paid by the driver of the vehicle. This is without prejudice to the right of a duly authorised officer of the Borough Council to waive some or all of such fee as they see fit.
