What is proposed?: To implement a 10% increase in the fares that Hackney Carriage drivers charge to the travelling public.

Why are the changes being introduced?: An agreement was reached with the Hackney Carriage trade in Ipswich that annual fare increases would be in line with the Consumer Price Index for the previous 12 month period. Hackney Carriage drivers can only charge the fares that the Council has approved and it is important that the fares are reviewed annually to enable these drivers to continue to earn a living.

What evidence is being used to support this Equality Impact Assessment, and how is it being used?: Average Consumer price index for the 12 months prior to the report.

How will this change be implemented?: The proposed fares will be publicised in the local newspaper and will be communicated to the trade via the Taxi and Private Hire Times newsletter. If any objections are received, the report will be reconsidered by Executive Committee. Once agreed, every taxi meter in hackney carriages in Ipswich will be re-programmed with the new tariff, tested over a measured distance and sealed by a Council Officer.
