Title of report: Polling District Review 2023-25

Report : The report sets out proposed changes to a number of polling districts and polling places as part of a review carried out under Section 17 of the Electoral Registration and Administration Act 2013.

The proposals have taken account of the representations received during a public consultation and have attempted to ensure that there is a balance of the electorate within each polling district and that polling places are convenient and easily accessible for voters.

Council is asked to agree the polling districts and polling places amendments, as set out in the attached schedules.

What is proposed?: Changes to the location of 3 polling stations within the Borough.

Why are the changes being introduced?: To improve the facilities and accessibility for voters and staff working in a polling station.

What evidence is being used to support this Equality Impact Assessment, and how is it being used?: Feedback from public and stakeholders from the 6 week consultation period. Guidance from the Electoral Commission regarding accessibility for polling stations. Legal considerations about complying with accessibility requirements for a polling station.

How will this change be implemented?: If agreed at Council on 24 January 2024, affected voters will be informed of the change of location to their allocated polling station via a poll card in March 2024, ready for the next scheduled election on 2nd May 2024. The poll card will give details about the new location and provide options for voters to use the postal or proxy voting methods if they do not wish to vote in person at the new polling station location. The polling stations "accessibility look-up" on the IBC website will be updated to reflect available accessible facilities at the new locations.

Age: Positive

Please provide an explanation of this impact and actions to mitigate any adverse impact, or further promote positive impact.: The change of polling station location will improve the accessibility and facilities at the venue for all adults over the age of 18 years old. For older people (or any adult) who may find the distance from their home to the polling station has increased due to this change, other voting methods exist as an alternative to in-person voting: postal or proxy voting.

Voter turnout for these locations will be considered to see if if has been increased / reduced.
