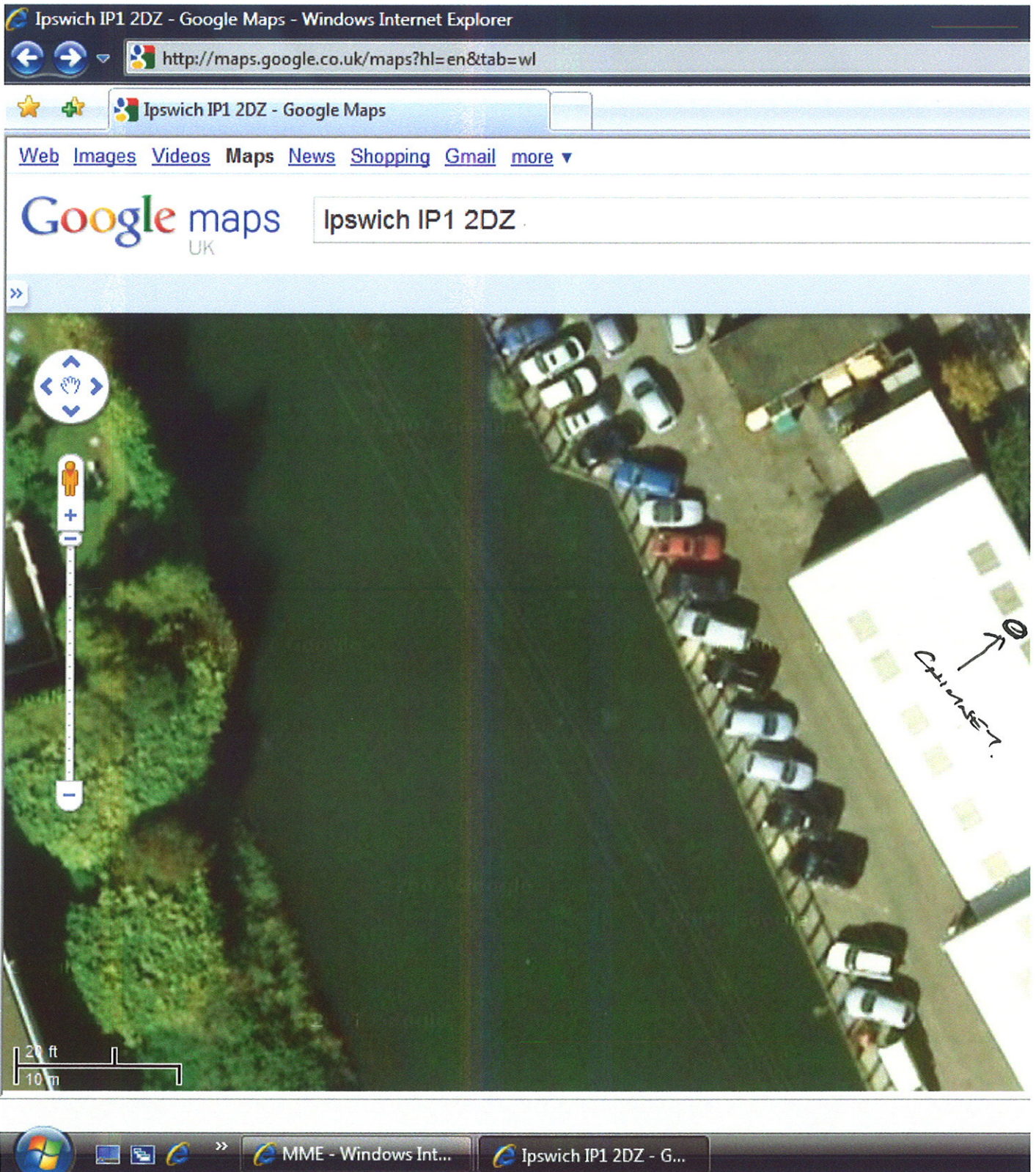

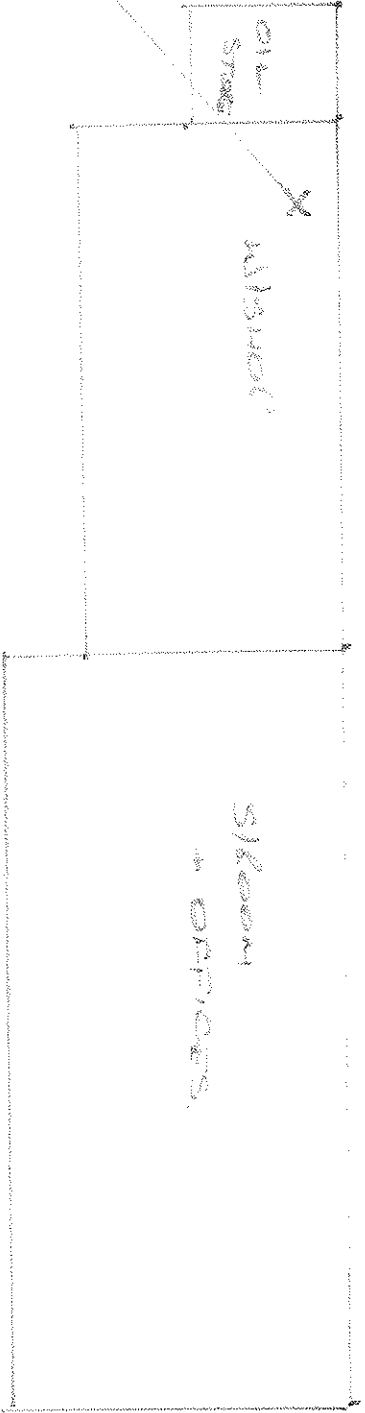

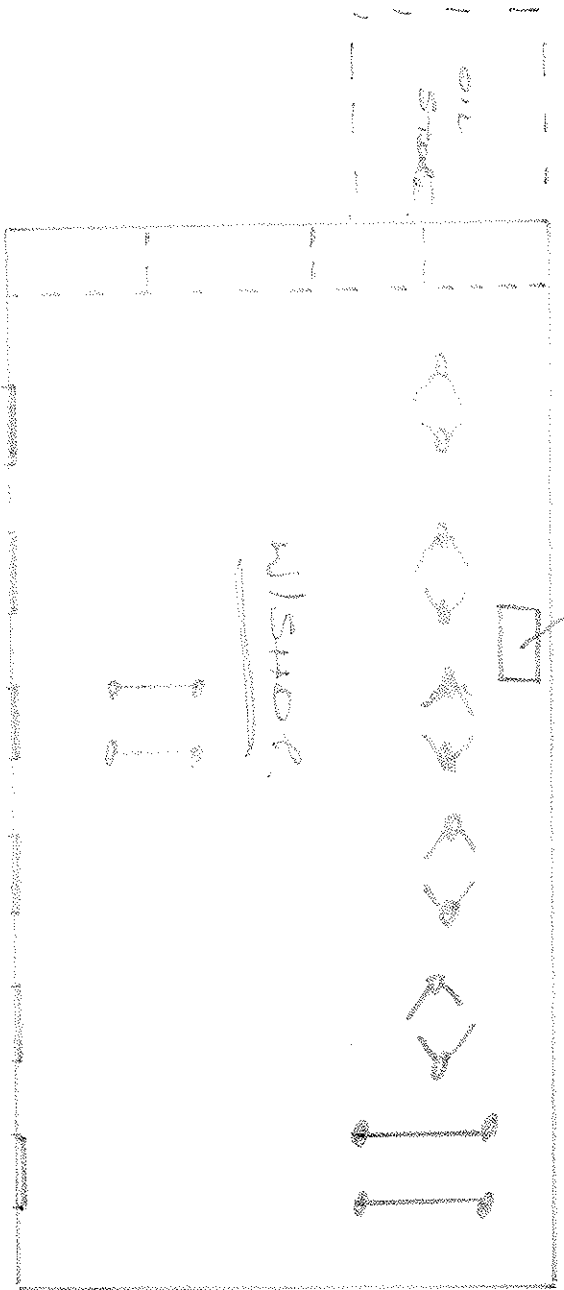


ROAD TO FRONT
