NOTICE IS HEREBY GIVEN that the First Secretary of State has now approved (without modification) the Direction made by the Ipswich Borough Council ('the Council') on 21 October 2004 pursuant to Article 4(1) of the Town and Country Planning (General Permitted Development) Order 1995 ('the 1995 Order') which affects certain properties abutting The Walk and The Thoroughfare within the Central Conservation Area.

The effect of the Direction is that the type of development specified in the Direction may no longer be carried out at those properties, which include a property of which you are the owner or occupier, without a grant of planning permission. Before such development can be undertaken it is necessary to apply to the Council for planning permission. No planning application fee will be payable for applications required as a result of the Direction.

Development for which planning permission will now be required is:-

The painting of the exterior of any building being development comprised within Class C of Part 2 of Schedule 2 to the 1995 Order and not being development comprised within any other Class.

A copy of the Direction was served with the earlier Notice served upon you on 21 October 2004.

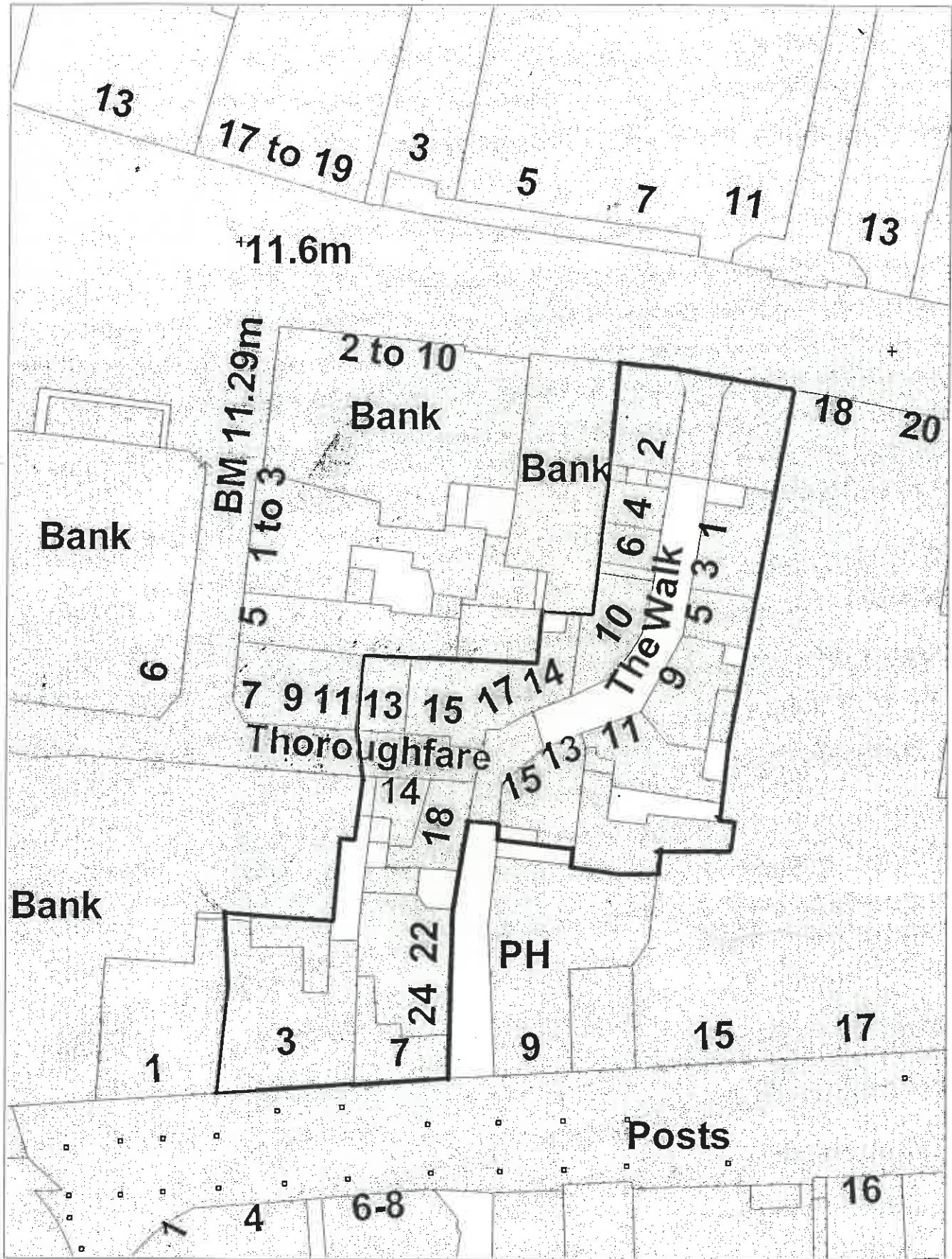
