

#### **Electoral Registration Officer - Privacy Notice**

#### Introduction

The Electoral Registration Officer has provided this privacy notice to help you understand how we collect, use and protect your Personal Data which we hold in order to comply with our duties under The Representation of the People Act 1983.

When reading this document please note that we use the terms 'Personal Data' and 'Personal Information' interchangeably.

The document below will describe how we may collect and process your personal information.

The purpose of this document is to clearly acknowledge the Electoral Registration Officer's responsibilities in relation to the United Kingdom General Data Protection Regulation (GDPR) and the Data Protection Act 2018 (DPA 2018).

Under Representation of the People Act 1983, each Local Authority is required to appoint an *Electoral Registrations Officer*, who is responsible for administration of the Electoral Roll and acts as data controller for this information.

## Definitions used in this Notice

**Personal Data** means any information related to an identified or identifiable living individual- known as a 'data subject'.

An individual is regarded as identifiable if they can be identified, directly or indirectly, in particular by reference to an identifier such as a name, an identification number, location data or an online identifier such as an IP address or cookie identifier. Alternatively they can also be identified by one or more factors specific to the physical, physiological, genetic, mental, economic, cultural or social identity of the individual.

**Special Personal Data** previously known as 'sensitive personal data', relates to race, ethnic origin, politics, religion, trade union membership, genetic data, biometric data (where used to identify a person), health,



sex life or sexual orientation. Records of personal data relating to criminal convictions and offences and allegations must be treated in a similar way.

**Processing** means any operation which is performed on information such as. collection, recording, organisation, structuring, storage, adaption or alteration, retrieval, consultation, use, disclosure by transmission, dissemination or making available, alignment or combination, restriction, erasure or destruction.

**Data Controller** determines the purposes and means of processing personal data.

**Data Processor** is a third party who processes personal data on behalf of the Controller

**Third Party** is someone / somebody who is not the Data Controller, the Data Processor or the Data Subject.

#### Who we are and what do we do:

The Electoral Registration Officer and Electoral Services Team are responsible for the administration of the electoral roll in the borough of Ipswich. This includes processing applications for registration onto the electoral roll and annual renewals of the electoral register. This information is shared with the Returning Officer in order to administer elections.

Your personal data is being processed under Article 6 (c) [legal obligation] or (e) [public task].

The Electoral Registration Officer regards the lawful and correct treatment of personal information as critical to their successful operations, maintaining confidence between themselves and those with whom they carry out business. The Electoral Registration Officer will ensure that they treat personal information correctly in accordance with the law.

## What information do we maintain?

We will only collect and use the minimum information needed.

The information about you which we will maintain may include:

- Name
- Contact details
- Address
- Date of birth
- Nationality
- Elector number
- Postal Voting personal identifier (Signature and DOB)
- Signature
- Information regarding why an elector is unable to sign a postal vote, which may include disability and health information,
- Previous address
- Overseas correspondence address for overseas voters
- National Insurance number (this is redacted once registration is complete)
- If the elector is in the Armed Services, the service they are employed with, a correspondence address and Service Personnel number
- Where a proxy vote has been requested, the name of the proxy voter, their address and their contact details

## How do we use your information?

We will be using your information to:

- Administer elections including production of poll cards, postal vote packs etc, and maintain the electoral register in accordance with the law
- Process applications to register to vote
- Check eligibility to vote and ensure only those entitled to vote are registered.
- Prevention and detection of criminal activity
- Assist the Council's response to national emergencies
- Data matching for the DWP

We will not use your personal data for other purposes other than for what it was collected unless we have obtained your consent or for other lawful purposes (e.g. detection and prevention of fraud).

Please note that the law permits the sale of copies of the Open Electoral Register. The information contained in this register is the name/s of electors at the property, elector number/s and address. You have the right to opt out of being on the Open Register. Please contact the Electoral Services team for further information.

Automated processing/profiling:



	The Electoral Registration Officer does not undertake any automated decision-making including profiling with the information collected.						
How long do we keep your information?	<ul> <li>We will hold your personal information in line with the Electoral Registration Officer's Retention Policy as follows:</li> <li>Information on the Electoral Register is held in perpetuity as a historical asset and for the purpose of law enforcement.</li> <li>Information relating to postal voters is held for the lifetime of the elector's postal vote.</li> <li>Information relating to proxy voters is held for the lifetime of the elector's proxy vote.</li> <li>Where you choose not to register as an elector, the information will be held until either you register to vote, move address or confirm you are not eligible to register to vote.</li> </ul>						
	You have the right to request that your personal information is deleted at any time, however whether this is possible will depend on the reasons why the data is processed. The Electoral Registration Officer will consider your request and comply where possible. If it is not possible, we will explain the reasons to you.
