

## **Ipswich Borough Council Draft Local Validation List 2022 Equality Impact Assessment**

### **What is the report trying to achieve?**

The report seeks authorisation to undertake public consultation on the Ipswich Borough Council draft Local Validation List 2022. A Local Validation List provides guidance about the level and type of information required to accompany each type of planning application to enable it to be validated. Updating the Local Validation List will ensure planning applications can continue to be assessed effectively and expediently, as part of the Council's commitment to deliver an efficient and high-quality development management service and support the delivery of new housing and infrastructure.

### **What evidence/data is being used to support this equality analysis?**

Published data - e.g Census, State of Ipswich report.

### **What is proposed?**

The report seeks authorisation to undertake public consultation on the Ipswich Draft Local Validation List 2022.

### **Why are changes being introduced?**

Paragraph 44 of the National Planning Policy Framework (July 2021) ("NPPF") requires local planning authorities to publish a list of requirements for applications for planning permission, these requirements should be kept to the minimum needed to make decisions and should be reviewed at least every 2 years.
