What is proposed?: A report that reviews and updates Executive on the operation and impact of the Area Committees in Ipswich for 2023/24 as per the Constitution Part 3 Section 2 paragraph 6.4.4.

Area Committees were constituted in December 2011 in response to the Localism Act 2011 and are formal committees within the definition of the Local Government Act 1972 and involve all Ipswich Borough Councillors.

These public meetings of ward Councillors were created to:

- Make decisions on local issues
- Influence the Councils strategic agenda
- Influence partner organisations' policy making
- · Engage with residents about what they would like to see in their local area
- Encourage public participation
- Achieve better services
- Strengthen democratic accountability

Area Committees have devolved powers to make decisions. Each committee has a budget allocated as part of the annual budget setting process. The total sum is divided by 16 (number of wards) and then multiplied by the number of wards represented by the Area Committee. Each Area Committee can meet up to five times a year, 25 out of 25 meetings went ahead in the 2023/24 year.

Why are the changes being introduced?: There are no changes being introduced. This report is to review and update executive on the impact of Area Committees in the 2023-24 municipal year.

Every Area Committee has an Area Action Plan. All ward Councillors are invited to set the priorities for their relevant Areas at the beginning of the municipal year. In the 2023-24 municipal year, all five Area Committee Area Action Plans selected 'Health and Disability' or 'Promoting Community

Wellbeing and Fairness in Ipswich' as a priority. Budgets are mostly spent in line with the Area Action Plans, which means that all five areas actively looked to allocate funding to support local residents with their health and/or disability.
