

# Ipswich Council Tax 2023/24

## Frequently asked questions

### How much has my bill gone up by?

Ipswich Borough Council has increased by 2.97%

Suffolk County Council has increased by 3.99%

- 2% for adult social care

- 1.99% for general Council Tax

The Police and Crime Commissioner has increased by 6.03%

For a Band B property in Ipswich this equates to:

Ipswich Borough Council 17p per week

Suffolk County Council 86p per week

Police and Crime Commissioner 22p per week

### **Adult Social Care Precept**

The Secretary of State made an offer to adult social care authorities. ("Adult social care authorities" are local authorities which have functions under Part 1 of the Care Act 2014, namely county councils in England, district councils for an area in England for which there is no county council, London borough councils, the Common Council of the City of London and the Council of the Isles of Scilly.)

The offer was the option of an adult social care authority being able to charge an additional "precept" on its council tax without holding a referendum, to assist the authority in meeting its expenditure on adult social care from the financial year 2016-17. It was originally made in respect of the financial years up to and including 2019-20. If the Secretary of State chooses to renew this offer in respect of a particular financial year, this is subject to the approval of the House of Commons.

### **How is the Adult Social Care precept calculated?**

On your Council Tax bill, the increase in the charge (or precept) for Adult Social Care is shown as 2%.

This 2% is the increase in the charge for Adult Social Care as a proportion of Suffolk County Council's total charge for 2023/24 (Band D equivalent £1,496.43)

The increase between this year's and last year's Adult Social Care charge is 18.01%.

This means that for a band D property, the increase is £28.78, as last year's amount was £159.75 and this year's is £188.53.
