Summary

The Conservation of Habitats and Species Regulations 2017 (as amended) require local authorities to assess the impact of their local plan on the internationally important sites for biodiversity in and around their administrative areas. These sites - Special Protection Areas, Special Areas of Conservation and Ramsar sites - are known as European sites. The task is achieved by means of a Habitats Regulations Assessment (HRA).

An HRA asks very specific questions of a plan. Firstly, it 'screens' the plan to identify if there is a risk that certain policies or allocations may have a 'likely significant effect' on a European site, alone or (if necessary) in-combination with other plans and projects. If the risk of likely significant effects can be ruled out, then the plan may be adopted but if they cannot, the plan must be subjected to the greater scrutiny of an 'appropriate assessment' to find out if the plan will have an 'adverse effect on the integrity' of the European sites.

Following an appropriate assessment, a Plan may only be adopted if an adverse effect on the integrity of the site can be ruled out.

This document is an addendum to the HRA for the Ipswich Borough Council Local Plan Core Strategy and Policies Development Plan Document Review at Final Draft stage (undertaken in January 2020, with an addendum in May 2020 that reviewed additional pieces of evidence relating to air quality and flood risk) and has been produced alongside the Main Modifications to the Plan. This update should be read alongside the previous HRA report, which was able to conclude that the Plan would not result in adverse effects on European site integrity.

Following Main Modifications of the Core Strategy, the previous HRA conclusions have been checked and all Main Modifications reviewed. None of the Main Modifications change the previous conclusions or findings of the HRA of the Final Draft Plan.

As such, adverse effects on integrity, alone or in-combination are ruled out for all European sites as a result of the Plan at Main Modifications.

1. Introduction

- 1.1 The Ipswich Borough Council Local Plan Review (the Plan) was submitted to the Secretary of State for independent examination in June 2020. Following the close of the Examination Hearing, in December 2020, the Inspectors wrote to the Council setting out their views on the next steps for the examination of the Plan. This includes public consultation on the Main Modifications identified and discussed during the hearing that are required to make the Plan legally compliant or sound.
- 1.2 The designation, protection and restoration of European wildlife sites is embedded in the Conservation of Habitats and Species Regulations 2017, as amended, which are commonly referred to as the 'Habitats Regulations'. The most recent amendments (the Conservation of Habitats and Species (amendment) (EU Exit) Regulations 2019¹) take account of the UKs departure from the EU.
- 1.3 The Habitats Regulations require local authorities to assess the impact of their local plan on the internationally important sites for biodiversity in and around their administrative areas². Together, these Special Protection Areas, Special Areas of Conservation and Ramsar sites are known as European sites. The task is achieved by means of a Habitats Regulations Assessment (HRA).
- 1.4 The HRA for the Plan was finalised in January 2020 (with a subsequent addendum in May 2020 that specifically reviewed further evidence relating to air quality and flood risk) and concluded that at a plan level, the Local Plan Review 2018-2036 will not result in adverse effects on European site integrity. This report is a review of the Core Strategy Main Modifications to check whether they influence findings of the previous HRA. This report should therefore be read alongside the previous 2020 HRA report.
- 1.5 All Modifications have been checked, with the focus on the Main Modifications.

 Appendix 1 summarises the schedule of Main Modifications to the Core Strategy

DPD with an additional column to record whether the modification has any implications with respect to the 2020 HRA. This provides a record that all modifications have been checked. Section 2 of this report focuses on those modifications that could have implications for the HRA and considers the changes with reference to the 2020 HRA.

2. Implications of Core Strategy DPD Proposed Modifications on the 2020 HRA of the Local Plan

- 2.1 A check of each modification has identified two changes to the Core Strategy DPD that affect the quantum of growth or locations for development and as such need to be considered in more detail. These are:
 - Changes to the overall numbers of dwellings from 8010 to at least 8280 (2018-2036) as set out in modifications to policy CS7 and the supporting text and tables. This level of change is an increase from 445 dwellings per annum to 460 dwellings per annum.
 - Policy CS11(and supporting text) propose extensions to the West Meadows site to provide pitches for Gypsies and Travellers. These are additions to the plan and therefore the implications for the HRA must be checked.
- 2.2 It should be noted that there are more substantive changes to the quantum and location of growth proposed through the Site Allocations Main Modifications (which are considered in a separate addendum).

Policy CS7 and overall quantum of growth

- 2.3 The modifications result in an increase level of proposed growth, from 445 to at least 460 per annum. The Council has set out a strategy to meet the requirement through a combination of strategic and more local allocations. In addition, it has reviewed the development potential through an updated Strategic Housing and Employment Land Availability Assessment (SHELAA) published in January 2020. The policy references the need to now allocate land to provide for at last 4,431 houses in the Borough.
- 2.4 The housing land supply now set out in CS7 is:
 - Ipswich Garden Suburb: 1,380 (3,500 minus 205 completions expected late 2036 and 1,915 granted planning permission in January 2020)
 - Northern end of Humber Doucy Lane (policy ISPA4): 449
 - Site allocations through policy SP2 of the Site Allocations Plan: 2,880
 - Windfall 2023-2036 (50 per annum): 650
 - Total: 5,359.
- 2.5 In the 2020 HRA, likely significant effects were triggered by Policy CS7, with risks identified relating to air and water pollution, water resources, recreation and urbanisation impacts.

- 2.6 In terms of recreation, the appropriate assessment section of the 2020 HRA concluded that the RAMS includes a comprehensive monitoring and review programme that allows for new growth to be incorporated into the programme of avoidance and mitigation measures. The strategy provides for mitigation across administrative boundaries and has numerous opportunities for expansion, and by collecting contributions per dwelling, it is therefore flexible to provide mitigation for varying numbers of houses, at least within the relatively small range of change set out in the modification. As such there is no change to the HRA findings with respect to recreation.
- 2.7 With respect to urbanisation, the appropriate assessment reviewed sites proposed within 1.5km of the Stour and Orwell Estuaries SPA/Ramsar and the overall level of change that might take place within close or direct proximity to the European site. The revised figures in CS7, as set out in the modification, have no meaningful change in the relative proportion of growth within 1.5km and do not affect the HRA conclusions in any way.
- 2.8 For water issues, there is no reference to water quality or supply as current threats or future pressures in the Site Improvement Plan for the Orwell and Stour Estuaries SPA and the supplementary conservation advice³ refers to the risk of eutrophication across the site as low. The 2020 HRA was able to rule out adverse effects on integrity as a result of water issues, including water supply, water quality and flood risk. The relatively small change in the overall quantum of growth do not affect the HRA conclusions in any way.
- 2.9 With respect to air quality, the 2020 HRA considered the potential risks to the Orwell Estuary SPA/Ramsar to be low because of the habitats present and adverse effects on integrity were ruled out, alone or in-combination. The modifications to the plan in terms of housing numbers do not pose any credible further risk, given the relatively small proportionate increase.
- The 2020 HRA did highlight that the potential risks from air quality to European 2.10 sites within Suffolk warrant a co-ordinated approach across local authorities with a comprehensive evidence gathering to inform the next plan review. This recommendation remains relevant.

Policy CS11 and extensions to the West Meadows site

- 2.11 Policy CS11 allocates two extensions to the existing West Meadows Gypsy and Traveller site, as shown on the Policies Map. These are:
 - IP400a an extension is proposed to the west of the existing site (0.38ha); and
 - IP400b to the east of the existing site (0.12ha)
- 2.12 The site is at the far north-west of the Borough and as such located well away (around 7km) from the Orwell Estuary SPA/Ramsar. Due to the location of the site, adverse effects on integrity alone can be eliminated for urbanisation, water issues and air quality and the location means further assessment considering incombination effects with other plans and projects would not change the outcome of the assessment. Adverse effects on integrity can therefore be ruled out alone or in-combination. For recreation, the site falls within the 13km zone and mitigation is provided through the RAMS, as set out in Policy DM8. This ensures cumulative impacts are addressed and adverse effects on integrity from recreation can therefore be ruled out alone, or in-combination.

3. Formal Integrity Test and Conclusions

- 3.1 The Ipswich Borough Council Local Plan Core Strategy and Policies Development Plan Document Review with Proposed Main Modifications has been subjected to an appropriate assessment and integrity test according to the statutory provisions laid out in the Habitats Regulations 2017 as amended.
- 3.2 The HRA of the Final Draft Plan (in 2020) concluded that the Plan would not result in adverse effects on integrity for any European site, alone or incombination with other plans or projects. Following the Core Strategy Main Modifications, the HRA conclusions have been checked and all Core Strategy Main Modifications reviewed. None of the Main Modifications change the previous conclusions or findings of the HRA of the Final Draft Plan. As such, adverse effects on integrity, alone or in-combination are ruled out for all European sites.
