Notice of Consultation on Ipswich Local Plan Review 2018-2036 Proposed Main Modifications

- 1. Core Strategy and Policies Development Plan Document Main Modifications
- 2. Site Allocations and Policies (incorporating IP-One Area Action Plan) Development Plan Document Main Modifications

The Ipswich Local Plan Review 2018-2036 (ILPR) was submitted to the Secretary of State on the 10th June 2020 for Examination and consists of the Core Strategy & Policies Development Plan Document, the Site Allocations & Policies (incorporating IP-One Area Action Plan) Development Plan Document, and the Policies Map and IP-One Area Inset Map. The Examination hearing sessions took place in between 24th November and 16th December 2020. The Inspectors wrote to the Council on the 10th March 2021 to confirm that the Examination can proceed to consultation on the proposed Main Modifications.

The Council is inviting comments on the proposed Main Modifications to the ILPR. Main Modifications are the changes considered necessary to make the plan sound / and or legally compliant. They are proposed without prejudice to the Inspectors' final conclusions on the ILPR which will take account of all representations submitted in response to this consultation. This is not an opportunity to raise again matters relating to other parts of the submitted ILPR that have already been considered by the Inspectors during the Examination. The consultation will commence at 9am on 29th July 2021 and conclude at 11.45pm on 23rd September 2021.

The Main Modifications have been subject to an updated Sustainability Appraisal and Habitats Regulations Assessment. Representations on both documents can be made during the consultation period. At the request of the Inspectors, the Council submitted a number of documents during and after the Examination Hearing in response to issues raised in discussions at the Hearing. These are listed in section K of the Core Document library on the Examination website at: <u>https://www.ipswich.gov.uk/Core-Document-Library-Page</u>. Representors may comment on the additional evidence contained in documents K1-K6 and K8-K25 insofar as it is relevant to their representations on the Main Modifications.

Alongside the consultation on the proposed Main Modifications to the ILPR, the Council will be publishing a list of Additional Modifications which it intends to make on adoption of the Plan. These are outside the scope of the Main Modifications, and the Council is not inviting comments on them, but are being published for completeness. In addition, the Council will be publishing a list of changes to the Policies Map for consultation alongside the Main Modifications. The Policies Map is not defined in statute as a development plan document and so the Inspectors do **not** have the power to recommend Main Modifications to it. The proposed changes will be made to the Policies Map upon adoption by the Council. However, the Council is inviting comments on the Policies Map proposed changes document below as a separate exercise:
