

NOTICE OF CONSULTATION FOR THE IPSWICH BOROUGH COUNCIL DRAFT LOCAL VALIDATION LIST 2022

Ipswich Borough Council is undertaking public consultation on the Ipswich Borough Council Draft Local Validation List 2022.

The Ipswich Borough Council Draft Local Validation List 2022 sets out the information that Ipswich Borough Council will require to be submitted prior to a planning application being validated.

Ipswich Borough Council's current validation requirements are undergoing review to reflect changes in planning legislation, policy and guidance.

The review of the Local Validation List will:

- Provide greater certainty to applicants about the type and extent of information required as part of their application at the earliest possible stage; and
- Ensure the Council has all the information it needs to determine applications in a considered and timely manner.

The Ipswich Borough Council Draft Local Validation List 2022 will be published for a six-week public consultation period commencing on **19 October 2022 at 9am**. The Council is seeking comments on the content of the Draft Local Validation List 2022.
