# NOTICE OF MAKING DIRECTION WITHOUT IMMEDIATE EFFECT MADE UNDER ARTICLE 4 (1) RELATING TO AREAS OF IPSWICH

NOTICE is hereby given that Ipswich Borough Council made a non-immediate Article 4 (1) Direction on the **9 May 2023**, under Article 4(1) of the Town and Country Planning (General Permitted Development) (England) Order 2015 (as amended).

The Article 4 Direction relates to change of use from Class C3 (dwellinghouses) of the Schedule to the Town and Country Planning (Use Classes) Order 1987 (as amended) to a use falling within Class C4 of that Schedule (House in Multiple Occupation). The Direction applies to areas within the following Wards of Ipswich: Alexandra; Bixley; Bridge; Castle Hill; Gainsborough; Gipping; Holywells; Priory Heath; Rushmere; St John's; St Margaret's; Westgate. These areas can be viewed on the map attached to the Direction.

The Article 4 Direction is a non-immediate direction, and subject to confirmation by the Council, will come into force on **1 June 2024**. Once the Direction comes into force the change of use of a dwelling house (C3) to a house in multiple occupation (C4) shall not be carried out unless planning permission is first granted for this change of use.
