Short description of report content and the decision requested:

This report sets out proposed changes to a number of polling districts and polling places as part of a review carried out under Section 17 of the Electoral Registration and Administration Act 2013.

The proposals have taken account of the representations received and have attempted to ensure that there is a balance of the electorate within each polling district and that polling places are convenient and easily accessible for voters. Council is asked to agree the polling districts and polling places, as set out in the attached schedules.

Wards affected:

Alexandra, Bixley, Bridge, Castle Hill, Gainsborough, Gipping, Holywells, Priory Heath, Rushmere, Sprites, St John's, St Margaret's, Stoke Park, Westgate, Whitehouse, Whitton.

1. Executive Summary

- 1.1 Under Section 17 of the Electoral Registration and Administration Act 2013, the Council is required to carry out a review of polling districts and places every 5 years. This review commenced on 1 October 2023 and must be concluded by 31 December 2025. The previous review was held in 2018.
- 1.2 The Electoral Services team has now undertaken a full review of all polling districts, places and polling stations in accordance with the legislative provisions and the Electoral Commission's guidance in readiness to be implemented for the next scheduled elections to be held on 2 May 2024.
- 1.3 For ease of reference, the following terms are defined by the Electoral Commission as:
 - polling district This is a geographical sub-division of an electoral area (e.g. a UK Parliamentary constituency, a ward or an electoral division.)
 It is the responsibility of the Borough Council to divide its area into polling districts and for keeping the polling districts under review.
 - polling place This is an area or building in which a polling station is located. There is no legal definition of what a polling place is, and it could be defined as tightly as a particular building or as widely as a sports field. It is the responsibility of the Borough Council to designate polling places and for keeping them under review.
 - polling station This is the actual area where the process of voting takes place and must be located within the polling place designated for a particular polling district. For example, a room within a school building or a mobile unit placed on a recreation ground. The Returning Officer for the particular election must provide a sufficient number of polling stations and allot the electors to those polling stations in a manner as she thinks the most convenient.
- 1.4 This review does **not** affect any ward, county division or Parliamentary constituency boundaries; this review is purely about the administrative subdivision of a ward into polling districts that are then assigned polling places.

2. Background

(a) Review Procedure

- 2.1 The steps that must be undertaken in carrying out a review and the persons to be consulted are determined by legislation:
 - (i) A review begins with the Council drawing up its proposals and publishing a notice at its offices and on its website stating that the review is to be held.
 - (ii) The Acting Returning Officer(s) for any Parliamentary constituencies, wholly or partly, contained in the Borough must be consulted on the Council's proposals and are required to make comments. Therefore, the Acting Returning Officers for the Ipswich and the Central Suffolk and North Ipswich Constituencies were invited to comment.
 - (iii) Representations on proposals must be sought from persons having particular expertise in relation to access to premises or facilities for persons who have different forms of disability. Electors also have the right to make representations. Groups invited to comment included local physical and sensory disability groups, along with local groups for people with mental ill health and/or learning disabilities. The consultation notice and background information were displayed on the Council's website and the public notice board in Grafton House window between 20 November and 29 December 2023 inclusive.
 - (iv) In addition, comments were sought from Members of Parliament for the constituencies affected by the review, from Borough and County Councillors and from local election agents.
 - (v) Once the consultation has been carried out, the Council must consider the responses and decide whether to confirm its proposals with or without modifications. The results of the review must be published.
- 2.2 The approach taken in carrying out the review of this Council's polling districts and polling places has been based on the Electoral Services team's knowledge of the existing districts and places, informed by the views of local Councillors and feedback from Presiding Officers, Poll Clerks and Polling Station Inspectors in recent elections. These sources have identified a small number of minor issues and efforts have been made to address these in the review.

(b) The Rules and Guidance for Conducting the Review

- 2.3 There are a number of points which the Council must take into account in designating polling districts and polling places. These include the following:
 - (i) All electors should have such reasonable facilities for voting as are practicable in the circumstances.

- (ii) Polling places should, as far as is reasonable and practicable, be accessible to all electors, including those who are disabled and, when considering the designation of polling places, the Council must have regard to the accessibility needs of disabled persons
- (iii) A polling place should be distinct enough to be capable of being described sufficiently clearly so that electors can identify and find their polling stations.
- (iv) It is possible to designate a polling place which is not within the polling district it serves if there are special circumstances.

(c) Accessibility for Persons with Disabilities

2.4 As indicated above Returning Officers are required to have regard to accessibility issues for people with disabilities when designating polling places. The premises used for polling stations in the Borough are all accessible 'so far as is reasonable and practicable'. Polling station staff are also trained to give whatever assistance is possible should this be required. This issue is one upon which feedback is sought from Presiding Officers and the Polling Station Inspectors after each set of elections.

(d) **Proposals**

- 2.5 A list of current polling stations can be seen in Appendix 1. Appendix 2 shows a summary of proposals for each polling district. Appendix 3 contains the details of the amendments to specific polling places and polling districts which were proposed in the consultation.
- 2.6 The review suggests a number of changes to polling stations for the Returning Officer to consider. This is an evolving process and where better options become evident, attempts will be made to obtain these. The location of polling stations is a decision made by the Returning Officer. Whilst the Returning Officer has the power to requisition the use of buildings provided from public funds, such as schools, she has no such powers in respect of private buildings.

(e) Comments Received During Consultation

- 2.7 The comments and suggestions received during the period of consultation on the review's proposals are set out in Appendix 4, as are the responses to them.
- 2.8 During consideration of the comments received, members of the Electoral Services Working Group suggested that the polling place for polling district MB (Sprites) would be a convenient polling place for polling district IA (Stoke Park). This will require the venue's suitability for a double polling station to be assessed which was not possible prior to the publication of this report. An assessment will be made and the result reported to Council.

3. Relevant Policies

- 3.1 Issues of effective local government reflect the identities, interests and wishes of local communities and to achieve convenient voting arrangements.
- 3.2 As part of the 2023 Corporate Strategy, the fourth priority of "promoting (community wellbeing and) fairness in Ipswich" is supported by providing a fair access to voting facilities across all polling districts in the Borough.
- 3.3 The Corporate Strategy priority 5 "a financially sustainable council providing good quality services" is supported by the polling district public consultation by allowing lpswich residents to input on this their voting needs and in turn being used to quide decisions for voting facilities on this.

4. Options Considered / Under Consideration

- 4.1 In Stoke Park ward two options were originally proposed and a further option was suggested during consultation with the Electoral Services Working Group:
- 4.2 Option 1 was to continue using a temporary mobile polling station; this option provides poor facilities for voters and staff, is costly and it is understood that the mobile polling station has caused confusion for voters in adjacent polling districts. Option 1 is therefore not recommended.
- 4.3 Option 2 is to move the polling station to the existing polling place at Willows Childrens Centre. This would result in improved and permanent voting facilities in an established polling place, however, it would require many voters to cross Birkfield Drive. Option 2 is recommended if Option 3 is not practicable.
- 4.4 Option 3 is to move the polling station to the existing polling place at the Belstead Arms. Subject to the assessment of the suitability of the venue for a "double" polling station, this would also result in improved and permanent voting facilities in an established polling place. The practicability of this option will be assessed and the results reported to Council.
- 4.5 There is one proposal each for Priory Heath ward and Whitton ward.

5. Consultations

5.1 As stated above, a public consultation exercise took place between 20 November and 29 December 2023 inclusive. Stakeholders and the public were invited to make recommendations and to provide feedback on the proposals. 17 responses were received and are shown in Appendix 4.

7. Environment and Climate Change

- 7.1 The Council has declared a climate change emergency and has resolved to start working towards becoming carbon neutral by 2030. All Council decisions should take into account and respond to the potential impact that they will have on the climate and wider environment.
- 7.2 The proposals in this report will not have a direct impact on the climate and wider environment.

8. Equalities, Diversity and Community Implications

- 8.1 The review of polling places and polling stations is likely to have a positive impact on equality and diversity issues as the venues must be reviewed in terms of accessibility.
- 8.2 A suitability and access checklist provided by the Electoral Commission was used when surveying each polling station.
- 8.3 An Equality Impact Assessment took place and concluded that there would be no negative impact for those with protected characteristics.

9. Crime and Disorder Impact

9.1 There are no crime and disorder impacts arising from this report. All polling places are required to have adequate lighting which helps to deter potential criminality in the vicinity.

10. Financial Considerations

- 10.1 The cost of the polling district and polling places review has been met from within existing Electoral Registration budget.
- 10.2 The proposals will have minimal effect on the cost of providing future elections.

11. Legal Considerations

- 11.1 The Electoral Registration and Administration Act 2013, Section 17 requires each authority to carry out a review of polling districts, polling places and polling stations within the 16 months beginning 1st October 2013 and every five years thereafter. Reviews are compulsory and must be conducted within the timescales provided by legislation.
- 11.2 Under Representation of the People Act 1983, Section 18A, local authorities must comply with following the legislative requirements regarding the designation of polling districts and polling places. This also includes complying with accessibility requirements.
- 11.3 The Elections Act 2022 Section 9 provides a duty for Returning Officers to provide each polling station with accessibility equipment and therefore the polling district review should consider the space required within a polling station for this.
- 11.3 Under Section 18D(1) of Representation of the People Act 1983, eligible persons can make an appeal against the conduction of the review by lodging an appeal with the Electoral Commission. This includes both the way in which the review was carried out and the outcome of the review.

12. Performance Monitoring

12.1 It is a statutory duty to carry out a full review of polling districts, polling places and polling stations every five years. In addition, the Returning Officer needs to review the locations of polling stations to ensure that these are placed in the most appropriate areas of a polling place to enable electors in that area to cast their vote.

12.2 Informal reviews take place after every election, using feedback from voters, polling station staff, polling station inspectors and venue owners. Logbooks from each poling station are reviewed, along with notes compiled during the polling station inspections.

13. Conclusions

13.1 The Council has undertaken a review of its polling district and polling places in accordance with the legislation and has considered the responses received in the consultation. The outcome will be a reasonably balanced distribution of electorate across the polling districts, in turn allowing easy access to polling places and with adequate and accessible facilities for voting in a polling station. The impact will enable the best available voting experience for the electorate of lpswich.

14. Recommendations

- 14.1 That Council note the findings of the Polling District and Polling Place Review 2023-25.
- 14.2 That Council agree either Option 2 (Willows Children's Centre) or Option 3 (Belstead Arms) for the Polling District IA, and that the option selected be incorporated into Appendix 2.
- 14.3 That Council agree the proposed amendments to polling districts and polling places, as set out in Appendix 2, as revised by the decision at 14.2.
- 14.4 That Council agrees to the formal publication of a final report on the Review of Polling Districts and Polling Places, as required by the Electoral Registration and Administration Act 2013.
- 14.5 That Council recommend to the Returning Officer the polling places and polling stations, as set out in Appendix 2, as revised by the decision at 14.2, for use at future elections until the next scheduled polling district review commences in 2028.





You are gathering information re voting accessibility for people with mobility issues. I have mobility issues and use a postal vote. I have encouraged my 90 year old mum to do the same. It's easier than trying to attend polling stations. I just wish putting papers into different envelopes wasn't quite so complicated.	Madeline Johnson - Individual	Postal voting can be a preferred method of voting for some people unable to access a polling station easily. Postal voting as a method of voting is beyond the scope of this review.
There is a long standing problem in that large print voting forms are still not available to aid those with a visual impairment. The current offering is to provide candidate information in large print and then a cardboard overlay to the normal sized voting form so that Visually Impaired folk that can read the large print information can index down the voting form using the template to place their cross. That is, if your particular polling station has such readily to hand. However if you are in receipt of a postal vote, which a great many disabled are, you have to chase down the large print information and a template for yourself – experience gained over a number of years representing those with a visual impairment who wish to exercise their voting right personally and privately would show this is not easy at all. Often all we receive when raising the	Stephen Hodgkiss – Suffolk Sight	All Ipswich polling stations provide handheld large print ballot paper templates and a tactile voting device to assist with marking the ballot paper. Polling station staff are trained to offer assistance when requested, for example by reading out candidate names in order from a ballot paper. Visually impaired voters are welcome to take their own device or a companion to assist if preferred. If there are any other reasonable adjustments that can be made to the polling station to assist a visually impaired voter, then we would encourage the voter to contact the elections office well in advance of an election to discuss. Although postal voting is beyond the scope of this review, assistance can be given to postal voters on an individual basis. Again, we would encourage any voter with a physical or sensory disability to contact the elections office to discuss how we can best assist.

issue with election officials and officers is a statement that "this is the process, we cannot change anything and if you cannot partake via this means then perhaps someone else can assist you completing the form"! The current situation needs to be modified to ensure those with any form of disability including a visual impairment have equal access and their privacy respected when taking part in the electoral process.

Previously a private sheltered housing complex allowed the hire of a communal room within its building, but this is no longer available. To keep the polling station within the IA polling district, a temporary mobile unit would need to be hired. Mobile units provide poor facilities for staff and voters and are extremely costly. Polling station IA will be considerably closer to all residential properties within polling district IA than the comparable distance for some other polling stations within the Borough. The turnout figures referred to occurred when the polling station was situated within the polling district (2022 - Vinnicombe Court, 2023 - Mobile Unit on Birkfield Drive) and so it is unlikely that lower than average turnout is caused by the location of the polling station.
