Personal Profile

Ivan is the Artistic Director and Chief Executive of Eastern Angles Theatre Company, a role he has held for nearly 40 years, being one of the founding members of the company which was set up in 1982. The company's focus on theatre with a sense of place and specifically East Anglian arts and heritage themes means that he has extensive knowledge not just of Ipswich but also many of the other towns and areas of East Anglia. He is especially concerned with Ipswich's need for a narrative appeal that will set it apart, draw visitors, employers and employees and serve as an important boost to residents in terms of local pride and recognition.

The Company has just taken over the old Suffolk Record Office site, adjoining its base at the Sir John Mills Theatre, to create the Eastern Angles Centre. This new space will enhance its community engagement provision in the West of Ipswich where it is already running homework clubs, holiday activities and digital drop-in services.

Eastern Angles is a National Portfolio Organisation (NPO) of the Arts Council and recognised as a leading touring company both regionally and nationally.

Born in Shotley, raised and schooled (Rushmere Hall Primary and Northgate Grammar) in Ipswich, Ivan went on to Bristol University where he researched the medieval theatre of Ipswich.

He is a Fellow of Suffolk New College, Chair of the East Anglian Traditional Music Trust and helped form New Heritage Solutions CIC of which he is a director. In 2004 he was awarded an honorary Doctorate of Letters from UEA through University Campus Suffolk. He is now chair of We Are Ipswich, a consortium of performing arts organisations and Arts Council NPOs, and a group with a passion for raising the profile of arts and heritage development opportunities in the town.

Personal Profile

Educated in Leigh-on-Sea, then at Southend College of Technology, and graduated from Thames Polytechnic (now Greenwich University) in 1981 with an honours degree in Mechanical Engineering. Embarked on a career in engineering but subsequently joined the family warehousing & distribution business.

In 1987, formed Anchor Storage Ltd at Kenton, near Debenham in Suffolk. Anchor Storage provides the full range of logistics services, primarily to importers through Felixstowe, the UK's largest port. Over the last two decades Anchor has moved away from general warehousing and now specialises in Internet Fulfilment and 3PL (Third Party Logistics).

Anchor Storage have been members of Suffolk Chamber of Commerce & Shipping for over 30-years and in July 2014 Stephen was appointed as a Non-Executive Director of the board. He stepped down from this role last year having completed two 3-year terms. During this time, he was an occasional contributor to the Chamber's Bank of England Panel and until 2018, was Chairman of their Transport & Infrastructure Board. As part of this role, Stephen was heavily involved with the 'No Toll Tax on Suffolk' campaign which successfully had the threat of tolls lifted on the new Huntingdon-Cambridge section of the A14. He is a strong advocate for Suffolk in his role as an 'Invest in Suffolk Ambassador' and have been recognised as one of the top 100 individuals most influential in the County's economy. In October 1973, Stephen became an apprentice of The Worshipful Company of Carmen (a London Livery Company) and in 2009, he followed in his late father's footsteps (Master 1993/94) and was voted onto the Court of Assistants. He served for 4-years as Chairman of the Cart Marking panel and has been a Benevolent Fund Trustee for the last 5-years.
